RESOLUTION OF JASPER COUNTY COUNCIL

RESOLUTION, pursuant to Section 2-404 (a) of the Jasper County Code of Ordinances, finding that the Sheriff Department has two purchases that exceed the County Administrator’s contracting/purchasing authority of \$25,000, and pursuant to Section 2-411, finding one of the purchases is a sole source procurement, and pursuant to Section 2-445, finding one of the purchases is through the use of a South Carolina state contract, and authorizing the County Administrator to execute the purchase agreements on behalf of Jasper County, and matters related thereto.

The goods and/or services required and provided for in this resolution include the following:

WHEREAS, Jasper County Sheriff Department desires to purchase a 19-foot fiberglass V-hull boat Pioneer 202 Interceptor using a South Carolina state contract number 4400026192 from Pioneer Boats state vendor number 7000016820 (See Exhibit A) ; and

WHEREAS, the purchase price of the Pioneer 202 Interceptor is \$71,744.97, which exceeds the contracting/purchasing authority of the County Administrator; and

WHEREAS, the funds to purchase the Pioneer 202 Interceptor are budgeted in the Sherriff Department Fiscal Year 2024 budget under NEW VEHICLES (Account Number 010-057-2307); and

WHEREAS, Jasper County Sheriff Department desires to purchase an electronic evidence extraction system from Cellebrite, a sole source provider (see Exhibit B); and

WHEREAS, the quoted purchase price of the electronic evidence extraction system is \$47,520.00; and

WHEREAS, the funds to purchase the electronic evidence extraction systems are allocated to multiple budgeted accounts as follows: COMPUTER

EQUIPMENT \$9,885.86 (Account Number 010-057-24760), CRIME TASK FORCE \$23,111.02 (Account Number 010-057-2895), and EQUIPMENT—NARCOTICS EQUIP \$14,523.12 (Account Number 010-057-5050); and

WHEREAS, the Cellebrite quote, number Q-384106-1 dated April 3,2024 expires on June 30,2024; and

WHEREAS, it is the opinion of the Jasper County Sheriff Department that the purchase of these items will allow the Sheriff Department to better serve the County and its citizens; and

NOW THEREFORE, BE IT RESOLVED by Jasper County Council, in the council duly assembled and by the authority of the same that Jasper County Council hereby is of the belief and finds that it is in the best interest of the County and its citizens to approve the requested purchases; and

FURTHER RESOLVED, the County Administrator is authorized to execute the purchase agreements for such goods and/or services as are customary and usual, for the amounts stated above.
