#### STATE OF SOUTH CAROLINA COUNTY OF JASPER RESOLUTION NO. R-2023-01

### A RESOLUTION RELATING TO THE BUSINESS AND LICENSURE OF PEDDLERS AND HAWKERS.

WHEREAS, S. C. Code of Laws Section 40-41-10, et seq., provides that no person shall as a hawker or peddler expose or sell any goods, wares and merchandise in any county in this State unless he has received and is ready to produce and exhibit a license of such county so to sell or expose for sale goods, wares and merchandise in such county; and

WHEREAS, S. C. Code of Laws Section 40-41-30 provides that the governing body of each county shall fix and establish such fees in its county at the first meeting in January of each year; and

WHEREAS, S. C. Code of Laws Section 40-41-90 provides for an exemption from the provisions of Chapter 41, Article 1, except for the provisions of Sections 40-14-70 and 40-41-100 (regarding sales within one-half mile of certain religious meetings and penalties), to vendors of newspapers, magazines, vegetables, tobacco, provisions of any kind or agricultural products or to sales by sample by persons traveling for established commercial houses, but provides for applicability to vendors of every other class and kind of goods, wares and merchandise and to sales by sample or otherwise by such hawkers and peddlers of stoves, ranges, clocks, lightning rods, sewing machines, pianos or organs; and

WHEREAS, Jasper County Council adopted a Business License Ordinance, codified at Section 8-31 *et seq.* of the County Code of Ordinances, which incorporates in Section 8-51 a Business License Schedule identified as "Exhibit B;" and

WHEREAS, Appendix B establishes a general classification as Rate Class 9.41 "NAICS CODE 454390 Other Direct Selling Establishments (Regular Peddlers)" which includes rates for both resident and non-residents; and

WHEREAS, Jasper County wishes to allow peddlers, hawkers and solicitors to operate only under prescribed conditions in accordance with the aforementioned statute, and confirm by Resolution the applicable fees for hawkers and peddlers;

NOW, THEREFORE, BE IT RESOLVED, by Jasper County Council, in a meeting duly assembled, as follows:

#### Section 1 - Definitions:

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this Resolution, except where the context clearly indicates a different meaning:

- a) "Peddler" means any person who goes from house to house or from place to place soliciting, selling or taking orders for or offering to sell or take orders for any goods, wares, merchandise, or services; except vendors of newspapers, magazines, vegetables, tobacco, provisions of any kind or agricultural products, to sales by sample by persons traveling for established commercial houses, or any other vendor specifically exempted by State Statute, and includes those who may otherwise be identified as "hawkers" or "solicitors."
- b) "County" means the County of Jasper.
- c) "License official" means a person designated to administer the County Business License program.
- d) "Person" means any individual, firm, partnership, LLP, LLC, cooperative non-profit membership, corporation, joint venture, association, estate, trust, business trust, receiver, syndicate, holding company or other group or combination acting as unit, in the singular or plural, and the agent or employee having charge or control of a business in the absence of the principals.
- e) "Profession" means a calling, occupation, or activity engaged in with the object of gain, benefit or advantage, either directly or indirectly.

<u>Section 2 - License and fee:</u> Every Person engaged in or intending to engage in the Profession of Peddler, in whole or in part, within unincorporated Jasper County, is required to pay an annual license fee to obtain a license.

- a) The required license fee shall be paid for each Peddler before commencing business and will be good in the County until the last day of December next after the date of issue.
- b) The license fee per Peddler shall be as follows for Persons with a principal place of business as provided for under the Business License Ordinance:

- 1. Resident: \$100.00 on the first \$2,000.00 of gross sales, plus \$1.00 per \$1,000.00, or fraction thereof, over \$2,000.00
- 2. Non-Resident: \$200.00 on the first \$2,000.00 of gross sales, plus \$2.00 per \$1,000.00, or fraction thereof, over \$2,000.00

<u>Section 3 - Application for Peddler license:</u> Any Person may apply for one or more Peddler licenses at the Clerk of Court' Office, or upon receipt by the Jasper County Administrator of a letter from the Clerk of Court requesting to delegate the administration the Peddler license program to the County License Official's office and a confirmation by the Administrator of such responsibilities, at the Jasper County Business License Office (in-person or on-line). The Clerk of Court, or in the case there has been a delegation of authority, the Business License Office, shall issue such permit upon payment of the applicable fee.

### Jasper County Council Presentation of Storage Array Proposals

Meeting Date:	January 3, 2023		
Subject:	Presentation of storage array proposals and acceptance of staff recommended proposal.		
Recommendation:	Accept proposal from Staples for the replacement of the current storage array in the amount of \$583,540.12 excluding sales tax (amount to be determined upon placement of the order) and authorize the County Administrator to negotiate and enter into all necessary purchase agreements for the project.		
Submitted for:	Acceptance of Staples proposal for the replacement of the current storage array in the amount of \$583,540.12 plus applicable sales tax and authorize the County Administrator to negotiate and enter into all necessary purchase agreements for the project.		

**Description**: The County advertised for proposals for a storage array with a due date of Thursday, November 17, 2022. The county received eleven (11) proposals. The review committee, consisting of Earl Bostick, IT Director, Russell Wells, Director of Emergency Services Div., and Kimberly Burgess, Director of Administrative Services Div., met on December 15, 2022 to discuss the proposals. The review committee determined that three (3) of the proposals met the requirements of the County and discussed the pros and cons of each of the three (3) top proposals. The Staples proposal was determined to the best solution for the County for the following reasons:

- 1) Proximity of parts and service,
- 2) Previous experience with HPE emergency response and support, and
- 3) HPE equipment is widely supported and used at the state level

Recommendation: Staff recommends that the Council accept the Staples proposal for the HPE storage array system for \$583,540.12 plus sales tax and authorize the County Administrator to negotiate and enter into all necessary purchase agreements for the project.

#### Good Afternoon All:

After our discussion and follow up of the Flash Storage Array systems, we came to the conclusion that the DCW, Staples, and Insight solutions were the top three. With that being said, we decided to look at the pros and cons of the three. Insight and DCW both provide Dell equipment in their solution. Staples provided HPE equipment in their solution. After further review, we determine that Staples solution would be the best option, due to the fact that HPE have a parts and response team that is base out of Charleston, which will put their 24x7 support and response approximately one hour and thirty minutes away from the county.

Also with that in mind, the county has great relationship with HPE when it comes to the emergency response and support. The equipment that was quoted with Staples is widely supported and used at the state level. The Dell equipment that was quoted by DCW and Insight; starting on the support level, Dell support has not been the best, nor has it been extremely dependable, which has created problems when it comes to EMS, Fire Rescue, 911, and Law Enforcement. When it comes to a support call, going out at 3am we need a rapid response for repair, this is not something that Dell is known for.

After further review of both quotes by Kim, Rusty and myself. My colleagues and I believe that the Staples-HPE solution would be the best solution that would work best for the county. Our relationship and history we have with HPE is must more reliable and dependable, then Dell.



The U.S. Fish and Wildlife Service (Service) published a notice in the Federal Register on November 22, 2022 (87 FR 71352), to announce the findings of our 5-year review of boundaries for the John H. Chafee Coastal Barrier Resources System (CBRS) units in Michigan, Minnesota, Mississippi, North Carolina, Ohio, Texas, Wisconsin, and ten units in South Carolina and availability of draft revised boundaries for stakeholder review and comment. This fulfills a directive in the Coastal Barrier Resources Act (CBRA) that requires the Secretary of the Interior (Secretary) to review the CBRS maps at least once every 5 years and make such minor and technical modifications necessary to reflect changes in the size or location of the units as a result of natural forces (16 U.S.C. 3503(c)). The law requires that these 5-year review modifications be made in consultation with the appropriate Federal, State, and local officials. We therefore invite you to review the draft boundaries and provide input during a 30-day stakeholder review period that will close on December 22, 2022. The Federal Register notice, a web mapping application depicting the proposed changes, and additional information can be found on our website: <a href="https://www.fws.gov/project/cbrs-5-year-review">https://www.fws.gov/project/cbrs-5-year-review</a>.

The CBRA of 1982 (16 U.S.C. 3501 et seq.) was enacted by Congress in 1982 and continues to serve as an important tool for saving taxpayer money, keeping people out of harm's way, and reducing the intensity of development on coastal barriers designated within the CBRS. The law does not prohibit or regulate development; however, it removes the incentives to build on these vulnerable and ecologically-sensitive areas by prohibiting most new federal expenditures and financial assistance, including flood insurance. Coastal barrier ecosystems serve as important habitat for fish and wildlife and protect mainland communities from the full impact of hurricane winds and storm surges. Units of the CBRS are present in 23 states and territories along the Atlantic, Gulf of Mexico, Great Lakes, U.S. Virgin Islands, and Puerto Rico Coasts.

The Secretary, through the Service, is responsible for administering CBRA, which includes maintaining and modernizing the official maps of the CBRS, consulting with federal agencies concerning proposed federal expenditures within the CBRS, and making recommendations to Congress regarding proposed changes to the maps. With three narrow exceptions, only Congress—through new legislation—can modify the maps of the CBRS to add or remove areas. These exceptions, which allow the Service to make limited administrative modifications to the

maps, include: (1) the 5-year review requirement which considers changes that have occurred due to natural forces such as erosion and accretion; (2) voluntary additions to the CBRS by property owners; and (3) additions of excess federal property to the CBRS (16 U.S.C 3503(c)-(e)). Changes that are outside the scope of this authority cannot be made by the Service administratively.

Following the close of the stakeholder review period, we will review the comments received from Federal, State, and local officials and make any changes that are appropriate and consistent with our authority to make administrative modifications to the CBRS. We will then prepare final revised maps, which will become effective upon our publication of a second notice in the Federal Register. We will send you a follow-up notification once the final maps are adopted. We look forward to your input and involvement in this process.
