Subject:	Presentation of quotations for the replacement of the HVAC unit at Robertville Community Center
Recommendation:	Council to approve the County Administrator to accept the quotation from R.S. Andrews of SC for a 5 ton York HVAC unit

**Description**: Jasper County advertised for sealed bids to replace the HVAC unit at Robertville Community Center. The bids were due at 2:00 PM on August 10, 2022. No bids were received. However, there were two quotations received prior to the determination that the HVAC replacement required a formal sealed bid process. The quotations were from R.S. Andrews of SC for two different brands of heat pump units, a Carrier 5 Ton for \$21,000 and a lead time of 18-22 weeks and the other was for a York 5 Ton for \$16,450.

**Recommendation**: Staff recommends that the County Council accept the quotation from R. S. Andrews of SC for the York 5 Ton heat pump for \$16,450 and to allow the County Administrator to enter into an agreement for the purchase and delivery of the equipment.
